

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Subsection (b)(2) of Section 1, Chapter V, Public Law 33-66 is
- 3 *amended* to read:

Public Information Program. The sum of no less than One 1 "(2) Hundred Fifty Thousand Dollars (\$150,000) shall be allocated from the 2 3 General Fund appropriation in Subsection (b)(1) for the *sole* purpose of 4 conducting an extensive public education and information program by the COD and the Free Association, Independence, and Statehood Task Forces, 5 pursuant to § 2109, Chapter 21, Title 1 GCA. No funds allocated herein shall 6 be expended for personnel; and *shall* be divided equally among the Task 7 Forces. Notwithstanding 5 GCA Chapter 5 or any other law, said funds shall 8 9 be expended exclusively as advised by the Task Forces and approved by 10 vote of the COD. The unexpended balance of funds appropriated in this 11 Section *shall not* lapse and *shall* continue to be available until fully expended. A complete record shall be published on COD's website within 12 13 thirty (30) days of such procurement and expenditures, and submitted to I14 Maga'låhen Guåhan and the Speaker of I Liheslaturan Guåhan."

15 Section 2. Subsection (b)(3) of Section 1, Chapter V, Public Law 33-66 is
16 *amended* to read:

17 **Continuing Appropriation.** The unexpended balance of the **"(3)** 18 funds appropriated to the COD for Fiscal Year 2015 shall not lapse and shall 19 be available to the COD, and divided equally among the Task Forces until fully expended; and notwithstanding 5 GCA Chapter 5 or any other law, 20shall be expended exclusively as advised by the Task Forces and approved 21 by vote of the COD. A complete record shall be published on COD's 22 website within thirty (30) days of such procurement and expenditures, and 23 submitted to I Maga'låhen Guåhan and the Speaker of I Liheslaturan 24 Guåhan." 25

Continuing Appropriation. The unexpended balance of the 1 "(3) funds appropriated to COD for Fiscal Year 2016 for the purpose of 2 3 conducting an extensive public education and information program shall not lapse and shall be available to the COD, and divided equally among the 4 Task Forces until fully expended; and notwithstanding 5 GCA Chapter 5 or 5 6 any other law, shall be expended exclusively as advised by the Task Forces and approved by vote of the COD. A complete record shall be published on 7 COD's website within thirty (30) days of such procurement and 8 9 expenditures, and submitted to I Maga'låhen Guåhan and the Speaker of I 10 Liheslaturan Guåhan."
