

**AN ACT TO AMEND SUBSECTIONS (b)(2) AND (b)(3)
OF SECTION 1, CHAPTER V, PUBLIC LAW 33-66; AND
SUBSECTION (b)(3) OF SECTION 1, CHAPTER V,
PUBLIC LAW 33-185, RELATIVE TO AUTHORIZING
CONTINUING APPROPRIATIONS TO THE
COMMISSION ON DECOLONIZATION FOR THE
PURPOSE OF CONDUCTING AN EXTENSIVE PUBLIC
EDUCATION AND INFORMATION PROGRAM FOR
FISCAL YEARS 2015 AND 2016.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Subsection (b)(2) of Section 1, Chapter V, Public Law 33-66 is
3 *amended* to read:

1 “(2) **Public Information Program.** The sum of *no less than* One
2 Hundred Fifty Thousand Dollars (**\$150,000**) *shall* be allocated from the
3 General Fund appropriation in Subsection (b)(1) for the *sole* purpose of
4 conducting an extensive public education and information program by the
5 COD and the Free Association, Independence, and Statehood Task Forces,
6 pursuant to § 2109, Chapter 21, Title 1 GCA. No funds allocated herein shall
7 be expended for personnel; and *shall* be divided equally among the Task
8 Forces. Notwithstanding 5 GCA Chapter 5 or any other law, said funds *shall*
9 be expended exclusively as advised by the Task Forces and approved by
10 vote of the COD. The unexpended balance of funds appropriated in this
11 Section *shall not* lapse and *shall* continue to be available until fully
12 expended. A complete record *shall* be published on COD’s website within
13 thirty (30) days of such procurement and expenditures, and submitted to *I*
14 *Maga’låhen Guåhan* and the Speaker of *I Liheslaturan Guåhan*.”

15 **Section 2.** Subsection (b)(3) of Section 1, Chapter V, Public Law 33-66 is
16 *amended* to read:

17 “(3) **Continuing Appropriation.** The unexpended balance of the
18 funds appropriated to the COD for Fiscal Year 2015 *shall not* lapse and *shall*
19 be available to the COD, and divided equally among the Task Forces until
20 fully expended; and notwithstanding 5 GCA Chapter 5 or any other law,
21 *shall* be expended exclusively as advised by the Task Forces and approved
22 by vote of the COD. A complete record *shall* be published on COD’s
23 website within thirty (30) days of such procurement and expenditures, and
24 submitted to *I Maga’låhen Guåhan* and the Speaker of *I Liheslaturan*
25 *Guåhan*.”

26 **Section 3.** Subsection (b)(3) of Section 1 of Chapter V of Public Law 33-
27 185 is *amended* to read:

1 **“(3) Continuing Appropriation.** The unexpended balance of the
2 funds appropriated to COD for Fiscal Year 2016 for the purpose of
3 conducting an extensive public education and information program *shall not*
4 lapse and *shall* be available to the COD, and divided equally among the
5 Task Forces until fully expended; and notwithstanding 5 GCA Chapter 5 or
6 any other law, *shall* be expended exclusively as advised by the Task Forces
7 and approved by vote of the COD. A complete record *shall* be published on
8 COD’s website within thirty (30) days of such procurement and
9 expenditures, and submitted to *I Maga’låhen Guåhan* and the Speaker of *I*
10 *Liheslaturan Guåhan.*”
