





AN ACT TO TRANSFER LOT NO. 427 IN THE MUNICIPALITY OF TALOFOFO, WITH AN AREA OF THREE THOUSAND TWO HUNDRED FORTY-THREE (3,243)SQUARE METERS, **FROM** THE **ADMINISTRATIVE JURISDICTION OF** THE CHAMORRO LAND TRUST COMMISSION TO THE GUAM POWER AUTHORITY FOR THE PURPOSE OF THE **EXPANDING** *TALOFOFO* **ELECTRICAL** SUBSTATION.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that § 8203 of Article 2, Chapter 8, Title 12, Guam Code Annotated, provides the

- 1 Guam Power Authority (GPA) with the authorization to acquire lands for the
- 2 purposes of constructing, improving, equipping, maintaining, repairing, renewing,
- 3 replacing and reconstructing the electrical system of GPA; and GPA has identified
- 4 property under the administrative jurisdiction of the Chamorro Land Trust
- 5 Commission (CLTC) for the purpose of expanding the Talofofo Electrical
- 6 Substation, and preparing the site for the future construction of an Energy Storage
- 7 System. These improvements are essential in meeting current and future growth
- 8 demands for electrical generation and distribution to the Island Wide Power
- 9 System (IWPS).
- I Liheslaturan Guåhan also finds that the Guam Power Authority has commissioned a 25.65 MW solar farm through NRG Energy (independent power producer) and a 275 KW wind turbine renewable energy as part of its integrated resource plan; and that the construction and installation of an energy storage system facility at the selected site will provide significant power output stabilization from the Dandan solar facility and wind turbing thus firming the net
- stabilization from the *Dandan* solar facility and wind turbine, thus firming the net
- 16 power output.
- 17 I Liheslaturan Guåhan further finds that considering the present and future
- ability of GPA to operate the IWPS, GPA desires that the CLTC convey Lot No.
- 19 427 in the municipality of *Talofofo* to GPA for the *Talofofo* Electrical Substation
- 20 expansion; and that such action is deemed in the best interest of both parties and
- 21 necessary for the land registration.
- Section 2. Authorization to Transfer Land to the Guam Power
- 23 Authority (GPA). Notwithstanding any other provision of law, rule or regulation,
- 24 I Liheslaturan Guåhan authorizes the Chamorro Land Trust Commission (CLTC)
- 25 to transfer to the Guam Power Authority (GPA) the existing Talofofo Electrical
- 26 Substation property, Lot No. 427 in the municipality of Talofofo, containing an
- area of three thousand two hundred forty-three (3,243) square meters, more or less,

- 1 as shown on the land registration survey map of Lot No. 427 in the municipality of
- 2 Talofofo, prepared by TG Engineers, filed under Instrument No. 806752 (Exhibit
- 3 A), for the construction of a new Energy Storage System. GPA shall, upon
- 4 acquiring the Conditional Grant Deed, submit to the court the land registration of
- 5 the property; and all land registration expenses *shall* be borne by GPA.

- (a) GPA *shall* pay for the appraisal of said property by two (2) different appraisers certified to do business on Guam, which *shall* be selected by the Administrative Director of the CLTC.
 - (b) GPA *shall* have said property surveyed and registered at its own expense.
 - (c) GPA *shall* work with the CLTC to determine an appropriate compensation for said property, to include, but not be limited to, purchase at fair market value, in-kind service exchange of equal value, or a combination of options to be approved by GPA, CLTC, and the Consolidated Commission on Utilities (CCU). GPA and CLTC *shall* have *no more than* one hundred eighty (180) days to finalize this compensation agreement.
- **Section 3. Proceeds.** All proceeds from the sale of Lot No. 427 in the municipality of *Talofofo shall* be deposited in the *Chamorro Land Trust Infrastructure and Survey Fund*, identified as Department of Administration Revenue Account Number 3669-57001.
- **Section 4. Rezoning.** Notwithstanding 21 GCA § 61637, or any other provision of law, rule or regulation, Lot No. 427 in the municipality of *Talofofo* is hereby rezoned from Agricultural Zone (A) to Public Facility Zone (PF) for the purpose of expanding the *Talofofo* Electrical Substation and constructing the Energy Storage System.
- 26 Section 5. Effective Date. This Act *shall* take effect upon enactment.

Section 6. Severability. If any provision of this law or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this law that can be given effect without the invalid provisions or applications and to this end the provisions of this law are severable.
