### BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. § 51302 of Article 3 of Chapter 51 of Title 10, Guam Code
- 3 Annotated, is *repealed* and *re-enacted* to read:

1

1 Recycling Revolving Fund. There is hereby created the "§ 51302. 2 Recycling Revolving Fund (Fund), which shall be maintained separate and 3 apart from any other funds, including the General Fund of the government of 4 Guam, and independent records and accounts shall be maintained thereof. 5 The Recycling Revolving Fund shall not be commingled with the General Fund and shall be kept in a separate bank account. All revenue generated 6 7 from recycling fees collected pursuant to this Article, including interest 8 earned, shall be deposited into the Recycling Revolving Fund and shall be 9 expended exclusively for the purposes authorized in Article 3 of Chapter 51 10 of Title 10, Guam Code Annotated. The funds deposited into the Recycling 11 Revolving Fund shall not be subject to the transfer authority of I 12 Maga'låhen Guåhan."
