



**AN ACT TO *AMEND* § 86107(a) OF CHAPTER 86, TITLE
10, GUAM CODE ANNOTATED, RELATIVE TO THE
MEMBERSHIP OF THE COUNCIL ON MENTAL
HEALTH AND SUBSTANCE ABUSE.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 86107(a) of Chapter 86, Title 10, Guam Code Annotated, is
3 hereby *amended* to read as follows:

4 “(a) There is within the Department an Advisory Council for Mental
5 Health, Alcohol and Drug programs and services known as the Advisory
6 Council. The Council *shall* consist of seven (7) members appointed by *I*
7 *Maga'låhi* (the Governor) and confirmed by *I Liheslatura* (the Legislature).

1 The members of the Council *shall* serve for three (3) years. At least one (1)
2 member *shall* be a parent whose child is a client of the Guam Behavioral
3 Health and Wellness Center.”
