





AN ACT TO AMEND § 86107(a) OF CHAPTER 86, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO THE MEMBERSHIP OF THE COUNCIL ON MENTAL HEALTH AND SUBSTANCE ABUSE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. § 86107(a) of Chapter 86, Title 10, Guam Code Annotated, is hereby *amended* to read as follows:

"(a) There is within the Department an Advisory Council for Mental

"(a) There is within the Department an Advisory Council for Mental Health, Alcohol and Drug programs and services known as the Advisory Council. The Council *shall* consist of seven (7) members appointed by *I Maga'låhi* (the Governor) and confirmed by *I Liheslatura* (the Legislature).

The members of the Council *shall* serve for three (3) years. At least one (1) member *shall* be a parent whose child is a client of the Guam Behavioral
