
CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LAHEN GUÁHAN



**AN ACT TO APPROPRIATE FUNDS FROM THE
FISCAL YEAR 2014 FUND BALANCE OF THE
TOURIST ATTRACTION FUND TO THE GUAM
POLICE DEPARTMENT FOR OVERTIME
COMPENSATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the sum of Four Million Dollars (**\$4,000,000**) from the unappropriated,
4 unallocated fund balance of the Fiscal Year 2014 Tourist Attraction Fund (TAF) is
5 available for appropriation.

1 **Section 2. Appropriation.** Notwithstanding § 30107 of Chapter 30, Title
2 11 GCA, the sum of One Million Two Hundred One Thousand Eleven Dollars
3 **(\$1,201,011)** is hereby appropriated from the unappropriated, unallocated fund
4 balance of the Fiscal Year 2014 Tourist Attraction Fund to the Guam Police
5 Department for overtime compensation accrued for Fiscal Year 2015.
6 Notwithstanding the general provisions of § 30107.1 of Chapter 30, Title 11 GCA,
7 this appropriation is *not* subject to transfer or use for any other purpose.
