
Dear Madame Speaker:


**CERTIFICATION OF PASSAGE OF AN ACT TO *I MAGA'LAHEN GUÅHAN***



**AN ACT TO APPROPRIATE FUNDS FROM THE  
FISCAL YEAR 2014 HOTEL OCCUPANCY TAX (HOT)  
SURPLUS FUND TO THE GUAM VISITORS BUREAU.**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that there exists Three Million Five Hundred Thousand Dollars (\$3,500,000) in the  
4 Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for appropriation.

5           **Section 2. Appropriation.** Notwithstanding any provision of law, the  
6 sum of Nine Hundred Thousand Dollars (**\$900,000**) is hereby appropriated from  
7 the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the Guam Visitors  
8 Bureau for operational needs and for the costs associated with hosting the

1 upcoming Pacific Asia Travel Association (PATA) meeting. Notwithstanding the  
2 general provisions of § 30107.1, of Chapter 30, Title 11 GCA, this appropriation  
3 *shall* continue to be available until expended and is *not* subject to transfer or use  
4 for any other purpose.
