



AN ACT TO APPROPRIATE THE SUM OF NINE THOUSAND NINE HUNDRED THIRTY DOLLARS AND SIXTY-SIX **CENTS** (\$9,930.66) FROM THE UNOBLIGATED BALANCE OF FUNDS PURSUANT TO PUBLIC LAW 32-225 TO THE GUAM POLICE DEPARTMENT TO **PURCHASE** HANDHELD PORTABLE RADIOS AND ACCESSORIES FOR LAW ENFORCEMENT OFFICERS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Appropriation of Unobligated Balance of Funds.
- 3 Notwithstanding any provision of law, from the unobligated balance of funds

- 1 pursuant to Public Law 32-225, the sum of Nine Thousand Nine Hundred Thirty
- 2 Dollars and Sixty-Six Cents (\$9,930.66) is appropriated to the Guam Police
- 3 Department and shall be used to purchase two (2) handheld portable radios and
- 4 accessories.
- 5 Section 2. Reporting Requirement. The Chief of Police shall submit a
- 6 report to I Maga'lahen Guåhan and I Liheslaturan Guåhan following the
- 7 enactment of this Act as to the obligations and expenditures of the funds, detailing
- 8 all transactions pertaining to the funds appropriated herein.
