




CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LÅHEN GUÅHAN





**AN ACT TO *AMEND* § 40128(f) OF ARTICLE 1,
CHAPTER 40 OF TITLE 5, GUAM CODE ANNOTATED,
RELATIVE TO ALLOWING MUNICIPAL PLANNING
COUNCILS TO REVIEW PROJECTS PROPOSED TO
THE GUAM LAND USE COMMISSION (GLUC); AND
TO AUTHORIZE THE DIRECTOR OF THE
DEPARTMENT OF LAND MANAGEMENT TO
INCLUDE THE MAYORS IN THE GLUC ZONING AND
CONSTRUCTION FORMS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Statement.** *I Liheslaturan Guåhan* finds that the
3 Mayors and Vice Mayors of Guam by law “are authorized to participate in the

1 consideration of capital improvements program by the Executive Branch. They
2 shall be allowed to express their views, make recommendations on proposed
3 projects for their respective districts.” Also, *I Liheslaturan Guåhan* finds that “all
4 government of Guam departments and agencies shall advise in writing and apprise
5 the Mayor of any public works project or activity to be undertaken in his district at
6 least five (5) days prior to the start of said project or activity. In case of an
7 emergency, said department or agency shall advise the Mayor of the same
8 immediately.” (P.L. 14-27:9, amended by P.L. 20-33:1)

9 More importantly, *I Liheslaturan Guåhan* finds that § 40128 of Chapter 40,
10 Title 5, Guam Code Annotated, empowers the Mayors and the Municipal Planning
11 Councils with certain powers, duties and responsibilities, including the right to
12 review and express a view on all variance applications, zone changes, and
13 government leases involving land within their districts, pursuant to §§ 61623,
14 61638 and 60115 of Title 21, Guam Code Annotated.

15 **Section 2.** Subsection (f) of § 40128 of Article 1, Division 4, Chapter 40, Title
16 5, Guam Code Annotated, is *amended* to read:

17 “(f) Review and express a view on all variance applications, zone
18 changes. and government leases involving land within their districts,
19 pursuant to §§ 61623, 61638 and 60115 of Title 21, Guam Code Annotated.
20 The Municipal Planning Council of each municipal district to be affected by
21 other proposed projects reviewed by the Guam Land Use Commission *shall*
22 review the request and express its opinion thereon by resolution adopted by
23 a majority of its members, and such resolutions *shall* be forwarded to the
24 Guam Land Use Commission.”

25 **Section 3. Amendment to Guam Land Use Commission (GLUC)**
26 **Zoning and Construction Forms.** The Director of the Department of Land
27 Management, serving as the Executive Secretary of the Commission, *shall* inform

- 1 the Chairman and members of the Guam Land Use Commission, meet and amend
- 2 the GLUC zoning and construction forms to provide for a written portion or
- 3 section on the form indicating the Mayor's review, expression, and/or position on
- 4 the matter.
