

AN ACT TO *ADD* A NEW § 10315 TO ARTICLE 3 OF CHAPTER 10, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO THE ONLINE AND PUBLIC DISCLOSURE OF MEDICAL LICENSES ISSUED BY THE GUAM BOARD OF MEDICAL EXAMINERS.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. A new § 10315 is hereby *added* to Article 3 of Chapter 10, Title

- 3 5, Guam Code Annotated, to read as follows:
- 4 "§ 10315. Special Requirement for Medical Licenses.
- 5 Within six (6) months of the enactment hereof, the Guam Board of 6 Medical Examiners *shall* publish, and update on a quarterly basis on its

website, a listing of licenses issued pursuant to Article 2 (Physicians Practice Act) of Chapter 12, Title 10, Guam Code Annotated, including the license holder's name, primary work address, work phone number, specialty, initial date of licensure, license status, and board certifications."
