1 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds
that there exists One Million Five Hundred Fifty Thousand Dollars (\$1,550,000) in

the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for
appropriation.

3 Appropriation. Notwithstanding any provision of law, the Section 2. 4 sum of Four Hundred Thousand Dollars (\$400,000) is hereby appropriated from the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the Guam Visitors 5 6 Bureau for the Guam Football Association for the purpose of hosting, attending, 7 and participating in the FIFA 2018 World Cup and the AFC Asian Cup 2019 8 preliminary joint qualification matches. Notwithstanding the general provisions of 9 § 30107.1 of Chapter 30, Title 11, Guam Code Annotated, this appropriation shall 10 continue to be available until expended, and is not subject to transfer or use for any 11 other purpose.
