






8 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF  
9 GUAM:

10 Section 1. Section 6114 is hereby added to Chapter 2,  
11 Title VII of the Government Code of Guam to read as follows:

12 "Section 6114. Schedule of fees for copy  
13 of documents. The Director of Finance, notwith-  
14 standing any other provision of law, is authorized  
15 and directed to collect the following fees for  
16 the furnishing of certified, authenticated, or  
17 photostat copies of records, documents, receipts,  
18 or other papers:

19 Copy of filed income tax return, without	
20 attachments	\$ 5.00
21 Copy of attachments to filed income tax	
22 return, per page	1.00
23 Copy of W-2 withholding tax statement	1.00
24 Copy of pay-in voucher or Treasurer's	
25 receipt	1.00
26 Copy of business or professional license	1.00
27 Copy of fishweir license	1.00
28 Copy of firearms certificate of regis-	
29 tration and permit	1.00
30 Copy of certificate of registration of	
31 articles of incorporation, domestic or	
32 foreign corporation	1.00

All laws inconsistent with the provisions  
of this section are hereby repealed to the  
extent of such inconsistency."

Section 2. This Act is an urgency measure and shall  
take effect upon its approval by the Governor.
