## Public Law 41 -- Third Guam Legislature 1955 (FIRST) Regular Session G. L. 84

## AN ACT

An Act to appropriate funds for certain capital improvement projects and for other purposes.

Be it enacted by the People of the Territory of Guam:

Section 1. There is hereby appropriated from any money in the Treasury not otherwise appropriated the sum of \$14,100 for the purpose of paying salaries due to ex-employees of the former Guam Bus Lines.

Section 2. There is hereby appropriated from any money in the Treasury not otherwise appropriated the sum of \$20,000 for the Public Utility Agency for the water development program of the United States Geological survey during fiscal year 1956.

Section 3. There is hereby appropriated from any money in the Treasury not otherwise appropriated the following sums for the listed projects of the Department of Public Works.

> A. For interim school construction and collateral equipment \$64,500

> B. For the George Washington High School Cafeteria 51,000

> C. For the purchase of vehicles and two fire-fighting equipment for the Department of Public Safety 32,500

Section 4. There is hereby appropriated from any money in the Treasury not otherwise appropriated the sum of \$245,000 for the erection of electric distribution lines by the Public Utility Agency.

Section 5. There is hereby appropriated from any money in the Treasury not otherwise appropriated the sum of \$15,000 for the Department of Land Management to assist in preparing suitable parks and monuments and the museum in the territory.

Section 6. There is hereby appropriated from any General Fund Surplus in the Treasury of Guam not otherwise appropriated the sum of \$700,000 for construction of permanent school plants and equipment therefor.

Section 7. Every appropriation made herein except those made in Section 1 and Section 2 above shall be available for expenses incident to the project for which the appropriation is made including the expenses of administration, planning, supervision, and other similar expenses. Each appropriation made herein except the appropriations made in Sections 1 and 2 shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 8. This Act is an urgency measure and shall become effective upon its approval by the Governor.
