9 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

10 Section 1. Section 4106 of the Government Code is hereby  
11 amended to read:

12 "Sec. 4106. UNCLASSIFIED SERVICE. The positions set  
13 forth herein shall constitute the unclassified service and  
14 are hereby assigned to the pay ranges established in  
15 Section 4103 of this Chapter as follows:

Section 2. It is the intent of the Legislature by the passage of this Act to increase the compensation of the positions of Judge of the Police Court, Judge of the Island Court, and the Chief Judge of the Island Court to the pay range specified in this Act, but not to affect any change in the compensation of any other class therein as the same may have heretofore been adjusted by the Governor of Guam pursuant to the provisions of Section 4117 of the Government Code.

Section 3. This Act is an urgency measure.
