

Substitute Bill by Committee
on Governmental Affairs.

An Act to amend Subsections .01 and .03 of, repeal Subsection .02 of, and to renumber Subsection .04 of, Section 19507 of the Government Code and to repeal Subsections .01 and .02 of and to amend and renumber Section .03 of, and to renumber Subsection .04 of, Section 19506 of the Government Code, and to repeal Section 19346 of the Government Code relating to the Tax Appeal Board.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Subsection .01 of Section 19507 of the Government Code is hereby amended to read as follows:

".01. Membership. The 'Tax Appeal Board', herein called the 'Board', shall be composed of the members and chairman of the Board of Equalization existing under authority of Chapter 4 of Title XX of the Government Code and the said chairman shall also act as chairman of the Board."

Section 2. Subsection .02 of Section 19507 of the Government Code is hereby repealed in its entirety.

Section 3. Subsection .03 of Section 19507 of the Government Code is hereby amended to read:

".03. Compensation. Members of the Board shall be paid at the rate of Fifteen Dollars (\$15) per day for each day on which the Board meets, as certified by the Treasurer of Guam. The members of the Board are also entitled to compensation for the reasonable and necessary expenses incurred in the course of their duties, as certified by the Treasurer."

Section 4. Subsection .04 of Section 19507 of the Government Code is hereby renumbered to Subsection .02.

Section 5. Subsection .01 of Section 19506 of the Government

1 Code, including Subparagraphs .0101, .0102, .0103 and .0104, is
2 hereby repealed in its entirety.

3 Section 6. Subsection .02 of Section 19508 of the Government
4 Code is hereby repealed in its entirety.

5 Section 7. Subsection .03 of Section 19508 of the Government
6 Code is hereby renumbered .01 and amended to read:

7 ".01. The Board shall put into writing any decision
8 of the Board and secure the signature of all members con-
9 curring."

10 Section 8. Subsection .04 of Section 19508 of the Government
11 Code is hereby renumbered to Subsection .02.

12 Section 9. Section 19346 of the Government Code is hereby
13 repealed in its entirety.
