An Act to amend the Election Law, Title III, Government Code of Guam, by amending Sections 2056 and 2058, and by adding a new Section 2058.1, with reference to the time and place of registration.

Be it enacted by the People of the Territory of Guam:

Section 1. Section 2056, Chapter 2, Title III, Government Code of Guam, is amended to read as follows:

"Section 2056. Affidavit of registration: making and contents. No person shall be registered as a voter except by affidavit of registration. The affidavit shall be made before the registration clerk of the district or municipality wherein such elector resides, or before a registration clerk in the Office of the Election Commissioner, and shall set forth all of the facts required to be shown by this title and the election manual."

Section 2. Section 2058, Chapter 2, Title III, Government Code of Guam, is amended to read as follows:

"Section 2058. Times for registration. The registration of electors shall be in progress during the last six days in August (Sundays excepted) during each even numbered year. During this period of registration transfer of registration for an election may be made from one precinct to another precinct. Such transfer will be made in the precinct to which the elector transfers."

Section 3. Section 2058.1 is added to Chapter 2, Title III, Government Code of Guam, as follows:

"Section 2058.1. Same: in Office of Election Commissioner. The registration of electors shall also be in progress in the Office of the Election Commissioner from July 1 through August 25 during each even numbered year at such times as the office is open for the conduct of business. During this period of registration transfer of registration for an election may be made from one precinct to another precinct. The Election Commissioner shall appoint one or more Registration Clerks from among subordinate officers and employees in the Office of the Election Commissioner which office shall be performed as a part of the regular duties of such officers and employees."

Section 4. During the year 1956, notwithstanding Section 3 of this Act, the registration of electors shall be in progress in the Office of the Election Commissioner from the fifth business day following the effective date of this Act through August 25.

Section 5. This Act is an urgency measure.
