## Public Law 107--Third Guam Legislature 1956 (SECOND) Regular Session G. L. 255 AN ACT

An Act to add Section 4105.1 to Chapter 2 of Title V, Government Code of Guam, relating to certain classes of positions in the Department of Education and the pay ranges to which such classes of positions are assigned.

## Be it enacted by the People of the Territory of Guam:

Section 1. There is hereby added to Chapter 2 of Title V, Government Code of Guam, Section 4105.1, to read as follows:

"Section 4105.1. Department of Education: certain classes of positions. Notwithstanding any other provision of law, there are the following classes of positions in the Department of Education, assigned to the following pay ranges:

All laws which are unavoidably inconsistent with this section are repealed only to the extent of such unavoidable inconsistency, and all executive actions which are unavoidably inconsistent with this section are superseded only to the extent of such unavoidable inconsistency."

Section 2. The increase in pay ranges provided in Section 1 shall become effective with the first pay period in September, 1956.

Section 3. In addition to all sums heretofore appropriated for the operation of the Department of Education for the fiscal year ending June 30, 1957, there is hereby appropriated for such purpose out of any General Fund Surplus in the Treasury of Guam not otherwise appropriated the sum of \$85,000.00.

Section 4. This Act is an urgency measure.

Approved August 10, 1956.
