

Public Law 112--Third Guam Legislature
1956 (SECOND) Regular Session
G. L. 231
AN ACT

An Act to appropriate funds for the continuation and/or completion of certain necessary capital and/or interim improvement projects within the Territory of Guam and for other purposes.

Be it enacted by the People of the Territory of Guam:

Section 1. There is hereby appropriated from any money in the Treasury not otherwise appropriated the following sums of money for the continuation and completion of certain necessary projects as herein set forth:

| A. To complete the construction of eight (8) staff houses and the 20 unit apartment | \$ 8,000 |
| B. For the continuation of the highways and paving construction program | 150,000 |
| C. For the Department of Land Management to continue the improvement program of Parks, Monuments and the Museum | 10,000 |
| D. For continuing construction, equipping and landscaping the New Guam Memorial Hospital | 300,000 |
| E. To complete the construction and to provide necessary facilities and collateral equipment for the Price School at Mangilao | 50,000 |
| F. For improvements at the Juvenile Home | 3,000 |

Section 2. There is hereby appropriated from any money in the Treasury not otherwise appropriated the sum of \$51,482 for interim school improvements and for the purchase of school equipment.

Section 3. The following sums are appropriated, out of any money in the Treasury not otherwise appropriated, to supplement the appropriation for the operation of the government of Guam for fiscal year ending June 30, 1957:

A. For the Department of Finance	\$ 64,709
B. For the Department of Public Works	17,265
C. For the Village Public Works, Commissioners of Guam	8,000

Section 4. There is hereby appropriated from any money in the Treasury not otherwise appropriated the following sums of the purposes herein set forth:

A. For the Welfare Fund	\$ 30,000
B. For the Student Loan Fund	25,000
C. Matching funds for the Geological Survey	20,000
D. For the purchase of School Buses	25,000

Section 5. In the event that the funds appropriated by Section 19 of Public Law 1, Second Special Session, Third Guam Legislature, are not all immediately needed for school construction and have not been committed, \$273,594 of said sum shall be utilized for the purpose of school construction in the northern section of the territory as selected by the Governor and be added to any funds for school construction now available therefor.

Section 7. The sum of \$8,000 appropriated by Section 6, Public Law 1, Second Guam Legislature, Third Special Session, is hereby reappropriated for use in the construction of eight (8) housing units for staff quarters of the govern-

ment of Guam.

Section 8. There is hereby appropriated from any money in the Treasury of Guam not otherwise appropriated the sum of \$25,000 for the establishment, maintenance, and operation of the experimental dairy provided for by Chapter 5 of Article XIII of the Government Code of Guam. This appropriation shall remain in effect until expended for the purposes for which it is made.

Section 9. There is hereby appropriated from any money in the Treasury of Guam the sum of \$10,000 to be placed in the revolving fund established by Section 12403 of the Government Code as the operating capital thereof.

Section 10. There is hereby appropriated from any money in the Treasury of Guam not otherwise appropriated the sum of \$13,800 for the purpose of providing additional compensation of 10% as a hazard allowance on the pay of firefighting personnel, Department of Public Safety.

Section 11. There is hereby appropriated from any money in the Treasury of Guam not otherwise appropriated the sum of \$3,000 for the purchase of playground equipment and facilities for Agana Heights.

Section 12. Every appropriation made herein shall be available for expenses incident to the project for which the appropriation is made including expenses of administration, planning, supervision, and other similar expenses. Each appropriation made under Sections 1, 2 and 4 shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 13. This Act is an urgency measure.
