16	Section 2. Section 23323, Title XXIV of the Government Code of Guam
17	is hereby amended to read:
18	"Section 23323. Same: same. (a) A dealer or distributor
19	applying for a special dealer plate or plates shall make written
20	application to the Department of Finance setting forth such
21	information, and accompanied by such proof of his status as a
22	bona fide dealer or distributor as may reasonably be required
23	by the Department.
24	(b) Upon granting any application, the Department shall
25	issue to the applicant a certificate listing the dealer plate or
26	plates assigned to the applicant. Dealer plate or plates shall be
27	numbered in a separate numerical series and bear a suitable mark
28	or symbol. Such plate or plates shall be used only for the purposes
29	described in Section 23322,"
