5 AN ACT TO AMEND ITEM G OF SECTION 1, PUBLIC
6 LAW 98, FOURTH GUAM LEGISLATURE, WITH REFER-
7 ENCE TO FACILITIES FOR THE COURTS OF GUAM AND
8 THE GUAM PUBLIC LIBRARY.

9 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

10 Section 1. Item G of Section 1, Public Law 98, Fourth Guam
11 Legislature, is hereby amended to read as follows:

12 "G. The sum of Sixty-Five Thousand Dollars (\$65,000)
13 for construction and preparation of facilities to provide
14 space for the courts of Guam and the Guam Public Library, and
15 for moving expenses in connection therewith and in connection
16 with occupancy of the new Administration Building. Space for
17 the Guam Public Library may be provided in the old Administra-
18 tion building. Provided, however, that such sum shall not be
19 utilized to provide such facilities within the Guam Congress
20 Building. .

21 Twenty-Five Thousand Dollars (\$25,000) out of the above
22 appropriation shall be utilized for renovation and alteration
23 of the old Administration Building, and for expenses involved
24 in moving the Guam Public Library to the same; Three Thousand
25 Dollars (\$3,000) out of the above appropriation shall be
26 utilized for moving expenses in connection with the occupancy
27 of the new Administration Building; and Thirty-Seven Thousand
28 Dollars (\$37,000) out of the above appropriation shall be
29 utilized to provide space for the Courts of Guam."

30 Section 2. This Act is an urgency measure.
