AN ACT TO AMEND ITEM G OF SECTION I, PUBLIC LAW 98, FOURTH GUAM LEGISLATURE, WITH REFER-ENCE TO FACILITIES FOR THE COURTS OF GUAM AND THE GUAM PUBLIC LIBRARY.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Item 6 of Section 1, Public Law 98, Fourth Guam Legislature, is hereby amended to read as follows:

> "G. The sum of Sixty-Five Thousand Dollars (\$65,000) for construction and preparation of facilities to provide space for the courts of Gusm and the Gusm Public Library, and for moving expenses in connection therewith and in connection with occupancy of the new Administration Building. Space for the Guan Public Library may be provided in the old Administration building. Provided, however, that such sum shall not be utilized to provide such facilities within the Guam Congress Building. -

> Twenty-Five Thousand Dollars (\$25,000) out of the above appropriation shall be utilized for renovation and alteration of the old Administration Building, and for expenses involved in moving the Guam Public Library to the same; Three Thousand Dollars (\$3,000) out of the above appropriation shall be utilized for moving expenses in connection with the occupancy of the new Administration Building; and Thirty-Seven Thousand Dollars (\$37,000) out of the above appropriation shall be utilized to provide space for the Courts of Guam." Section 2. This Act is an urgency measure.
