

Finance and Taxation

AN ACT MAKING APPROPRIATIONS FOR PERMANENT  
SCHOOL PLANTS, THE TERRITORIAL COLLEGE  
BUILDING, THE CONSTRUCTION OF PUBLIC HEALTH  
CENTERS, AND FOR OTHER CAPITAL IMPROVEMENT  
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available funds  
3 in the Unappropriated Surplus of the General Fund of the government of Guam,  
4 not heretofore appropriated, the sum of Sixty-Four Thousand Three Hundred  
5 Dollars (\$64,300) for the completion of the Territorial College.

6 Section 2. There is hereby appropriated from any available funds  
7 in the Unappropriated Surplus of the General Fund of the government of Guam,  
8 not heretofore appropriated, the sum of One Hundred Ten Thousand Five  
9 Hundred Seventy-Seven Dollars (\$110,577) for Permanent School Plants, speci-  
10 fically Tucson Junior-Senior High, Anderson Elementary, Tamuning Elementary  
11 and Sinajana Elementary Schools.

12 Section 3. There is hereby appropriated from any available funds  
13 in the Unappropriated Surplus of the General Fund of the government of Guam,  
14 not heretofore appropriated, the sum of Six Hundred Twenty-Three Thousand  
15 Eight Hundred Dollars (\$623,800) for construction of an elementary school  
16 and a junior high school in Barrigada and an additional twenty-four (24)  
17 classrooms at the present Andersen Elementary School.

18 Section 4. There is hereby appropriated from any available funds  
19 in the Unappropriated Surplus of the General Fund of the government of Guam,  
20 not heretofore appropriated, the sum of Eight Thousand Six Hundred Sixty-  
21 Seven Dollars (\$8,667) for the construction of Public Health Centers.

22 Section 5. This Act is an urgency measure.
