AN ACTIMAKING APPROPRIATIONS FOR THE OPERATION OF THE EXECUTIVE BRANCH OF THE GOVERNMENT OF GUAM FOR THE FISCAL YEAR ENDING JUNE 30, 1960, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAR:

Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund, of the government of Guam for the speration of the Executive Branch of the government of Guam for the fiscal year ending June 30, 1960, and are hereby added to appropriations made by Section 1 of Public Law 5-26:

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund of the government of Guam the sum of Five Hundred Thousand Boilers (\$500,000,00) for the government's contribution to the Government of Guam Retirement Fund.

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund of the government of Guam the sum of Two Hundred and Fifty Thousand Dollars (\$250,000,00) for allowable travel and transportation expenses of the Executive Branch of the government of Guam for the fiscal year ending

June 30, 1960.

Section 4. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Fifteen Thousand Dellars (\$15,000.00) for the Workmen's Compensation Fund established by Section 37042 of the Government Code of Guam.

Section 5. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund of the government of Guam the sum of Thirty Thousand Dollars (\$30,000,00) for a survey by a private organization of the personnel law and its operation, including consideration of such other allied items as compensation, employment problems, and the like. The funds appropriated by this Section shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 6. This Act is an urgency measure.
