AN ACT TO APPROPRIATE FUNDS FOR THE  
OPERATION OF THE LEGISLATIVE BRANCH  
OF THE GOVERNMENT FOR THE FISCAL  
YEAR ENDING JUNE 30, 1960, AND FOR  
OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the General Fund of the govern-  
4 ment of Guam the sum of One Hundred Seventy-Seven Thousand Dollars  
5 (\$147,000) <sup>Forty</sup> for the operation and contingent expenses of the Legislative  
6 Branch of the government for the fiscal year ending June 30, 1960.

7 Section 2. There is hereby appropriated from any available  
8 funds in the Unappropriated Surplus of the General Fund of the govern-  
9 ment of Guam the sum of Twenty-Five Thousand Dollars (\$25,000) for an  
10 outside independent audit of the books of the government for the fiscal  
11 year ended June 30, 1959, to be conducted under the general direction  
12 of the Executive and Legislative Branches of the government.
