

AN ACT TO AMEND SECTION 25114, SUBSECTION 25116(d) AND SECTION 25116.1, CHAPTER 2, TITLE XXVI AND SUBSECTION 19563.02 OF SUBCHAPTER C OF CHAPTER 6, TITLE XX, ALL OF THE GOVERNMENT CODE OF GUAM, RELATIVE TO PURCHASING AND EXPORTING ALCOHOLIC BEVERAGES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 25114 of Chapter 2, Title XXVI, Government Code of Guam, is hereby amended to read:

"Section 25114. Same: manufacturer. A person holding a manufacturer's license is authorized to manufacture and sell in packages, to persons holding manufacturer's or wholesaler's license, or to any person holding a valid retail or wholesale license under the Business License Law for export, or manufacture and export, the alcoholic beverages specified by the Board."

Section 2. Subsection 25116(d) of Chapter 2, Title XXVI, Government Code of Guam, is hereby amended to read:

"(d) In addition, a person holding a wholesale dealer's license is authorized to export or sell alcoholic beverages to any person holding a valid retail or wholesale license under the Business License Law for export."

Section 3. Section 25116.1, Chapter 2, Title XXVI, Government Code of Guam, is hereby amended to read:

"Section 25116.1. Purchase in Guam for Export. Any person holding a valid retail or wholesale license under the Business License Law may purchase and take delivery of alcoholic beverages from any person holding a wholesale dealer's license or a manufacturer's license for export. Each such purchase and export must be reported to the Administrator in accordance with regulations of the Board."

Section 4. Subsection 19563.02 of Subchapter C of Chapter 6, Title XX, Government Code of Guam, is hereby amended to read:

".02. The beverage so exported was not the subject of any sale within Guam, other than a sale for export under Subsection 25116(d), Section 25116.1, or Section 25114 of the Government Code of Guam or other than a transfer of substantially the entire stock in trade in addition to good will and franchise or other rights concerning the beverage upon which the tax has been paid."

Section 5. This Act is an urgency measure.
