AN ACT TO ADD A NEW SECTION 13213 TO THE
GOVERNMENT CODE OF GUAM RELATIVE TO STREET
NAMING.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Section 13213 is hereby added to the
3 Government Code of Guam to read as follows:

4 "Section 13213. Official street and highway names.
5 The plan as submitted by the Territorial Planning Commis-
6 sion renaming the streets in the Municipality of Agana,
7 Guam on Land Management Drawing E6-59S435 is hereby
8 adopted subject to the following changes:

9 (a) Cliff Drive, west of Route 4 is hereby changed
10 to West O'Brien Drive, and Cliff Drive extension,
11 east of Route 4 is hereby changed to East O'Brien
12 Drive.

13 (b) Third Street South, west of Route 4 is hereby
14 changed to West Saylor Street, and Third Street
15 South extension, east of Route 4 is hereby
16 changed to East Saylor Street.

17 (c) Second Street West is hereby changed to O'Hara
18 Street West.

19 (d) Fourth Street West is hereby changed to Seaton
20 Boulevard West.

21 (e) Fifth Street West is hereby changed to Murray
22 Boulevard West.

23 (f) Seventh Street West is hereby changed to Aspinall
24 Avenue West.

25 (g) The area presently bounded by Fourth Street West,
26 Marine 'A', Fifth Street West and Third Street
27 South is hereby named Skinner Plaza.

(h) The names or designation 'Marianas Boulevard',
'Senator Gibson Highway', 'Spruance Drive', 'Doctor
Sergeant Drive', and 'Padre Palomo Parkway', are
hereby rejected and stricken and deleted from
said plan.

(i) First Street West is hereby changed to Martyr Street
West."

Section 2. This Act is an urgency measure.
