
CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT MAKING APPROPRIATIONS FOR OPERATION OF THE DEPARTMENTS OF EDUCATION, MEDICAL SERVICES, PUBLIC SAFETY, THE OFFICE OF CIVIL DEFENSE, THE RECREATION COMMISSION, NIEVES M. FLORES MEMORIAL LIBRARY, AND THE DIVISION OF PUBLIC WELFARE FOR THE FISCAL YEAR ENDING JUNE 30, 1961.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There are hereby appropriated from any available funds in the unappropriated surplus of the General Fund, the following sums for operation of the Executive Departments and agencies set forth herein, for the fiscal year ending June 30, 1961:

Department of Education	\$ 3,499,517
Department of Medical Services	2,126,006
Department of Public Safety	752,415
Office of Civil Defense	14,704
Recreation Commission	10,000
Nieves M. Flores Memorial Library	28,974
Division of Public Welfare	90,800

Section 2. This act is an urgency measure.
