AN ACT MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE EXECUTIVE BRANCH OF THE GOVERNMENT FOR THE FISCAL YEAR ENDING JUNE 30, 1961, AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM: Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund to supplement appropriations previously made in Public Law 5-91, Public Law 5-92, and Public Law 5-98 for the operation of the Executive Branch of the government for the fiscal year ending June 30, 1961:

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Seven Thousand One Hundred Fifty Dollars (\$7,150.00) as a supplement to the appropriation previously made by Public Law 5-87 for the operation of the Judicial Branch of the government for the fiscal year ending June 30, 1961.

Section 3. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Five Thousand Two Hundred Sixty-Eight Dollars (\$5,268.00) to complete the government of Guam's contribution to the Retirement Fund for the fiscal year ended June 30, 1960.

Section 4. In addition to the funds appropriated in Section 1 hereof there is further appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Twelve Thousand Dollars (\$12,000.00) to the Department of Education as a further supplement to the funds previously appropriated in Public Law 5-98 for the operation of that department for the fiscal year ending June 30, 1961. The intent of this appropriation is to support the rehabilitation program of Guam Rehabilitation and Workshop Center, Inc., for the fiscal year ending June 30, 1961, as determined by the Board of Education.

Section 5. This Act is an urgency measure.
