
CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT TO REAPPROPRIATE A PORTION OF THE MONIES
APPROPRIATED IN PUBLIC LAW 5-96 AND TO APPROPRIATE
AN ADDITIONAL AMOUNT, FOR THE OPERATION OF THE
LEGISLATIVE BRANCH OF THE GOVERNMENT FOR THE
PERIOD FROM JANUARY 1 THRU DECEMBER 31, 1961,
AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby reappropriated from the monies
3 appropriated by Public Law 5-96, approved March 15, 1960, as amended by
4 Section 2 of Public Law 5-108, approved August 2, 1960, the sum of
5 Fifty-Seven Thousand Three Dollars and Eighty-Seven Cents (\$57,003.87)
6 for the operation of the Legislative Branch of the government for the
7 period from January 1, 1961 thru December 31, 1961.

8 Section 2. All expenditures and/or encumbrances recorded on
9 the books of the government against the appropriation made by Public
10 Law 5-96, which are applicable to the period subsequent to December 31,
11 1960 shall be transferred on the books against the appropriations made
12 in this Act.

13 Section 3. There is hereby appropriated from any available
14 funds in the Unappropriated Surplus of the General Fund the sum of One
15 Hundred Twelve Thousand Eight Hundred Thirty-One Dollars and Thirteen Cents
16 (\$112,831.13), as a supplement to the funds appropriated in Section 1 above
17 for the operation of the Legislative Branch of the government for the
18 period from January 1, 1961 thru December 31, 1961.
