AN ACT APPROPRIATING FUNDS FOR THE OPERATION
OF THE LEGISLATIVE BRANCH OF THE GOVERNMENT
FOR THE PERIOD BEGINNING JANUARY 1, 1962 AND
EXPIRING JUNE 30, 1962, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund of the
4 Government of Guam the sum of Fifty Thousand Dollars and No Cents
5 (\$50,000.00) for the operation of the Legislative Branch of the
6 government for the period beginning January 1, 1962 and expiring
7 June 30, 1962.

8 Section 2. There is hereby appropriated from any available
9 funds in the Unappropriated Surplus of the General Fund the sum of
10 Twenty Five Thousand Dollars (\$25,000.00) to the Legislative Printing
11 Fund.

12 Section 3. There is hereby appropriated from any available
13 funds in the Unappropriated Surplus of the General Fund the sum of
14 Twenty Five Thousand Dollars (\$25,000.00) as a supplement to the funds
15 previously appropriated in Public Law 6-14 for the operation of the
16 Legislative Branch of the government, for the period from January 1,
17 1961 thru December 31, 1961.

18 Section 4. Public Law 6-3 is hereby amended to provide that
19 that portion of the funds appropriated therein for the Legislative
20 Branch shall be for the calender year ending December 31, 1961.

21 Section 5. This Act is an urgency measure.
