AN ACT TO APPROPRIATE FUNDS FOR THE OPERATION OF
THE LEGISLATIVE BRANCH, ~~INCLUDING THE OPERATION~~
~~OF THE WASHINGTON REPRESENTATION OFFICE~~, FOR THE
CALENDAR YEAR ENDING DECEMBER 31, 1962.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby reappropriated from the moneys appropri-
3 ated by Public Law 47, Sixth Guam Legislature, the sum of Fifty Thousand
4 Dollars (\$50,000) for the operation of the Legislative Branch of the Government
5 of Guam for the period beginning January 1, 1962, and expiring December 31, 19
6 1962.

7 Section 2. All expenditures and encumbrances charged on the books
8 of the Government of Guam against the appropriation made by said Public Law 47,
9 Sixth Guam Legislature, which are applicable to the period subsequent to
10 December 31, 1961, shall be transferred on the books and charged against the
11 appropriation made by this Act.

12 Section 3. There is hereby appropriated from any available funds in
13 the Unappropriated Surplus of the General Fund the sum of One Hundred Seven
14 Thousand Dollars (\$107,000) for the operation of the Legislative Branch of the
15 Government of Guam for the period beginning January 1, 1962, and expiring
16 December 31, 1962, as a supplement to the moneys appropriated by Section 1 of
17 this Act.

18 Section 4. There is hereby appropriated from any available funds in
19 the Unappropriated Surplus of the General Fund the sum of Thirty-Eight Thousand
20 Dollars (\$38,000) for the Legislative Branch of the Government of Guam for the
21 operation and maintenance of the Washington Representation Office, pursuant to
22 the provisions and authorization of Resolution No. 266, Sixth Guam Legislature.

23 Section 5. This Act is an urgency measure.
