AN ACT TO AUTHORIZE THE PURCHASE OF PRIVATE LANDS IN THE AGAMA SHAMP FROM MONEYS PREVIOUSLY APPROPRIATED AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAR:

Section 1. The moneys beretofore appropriated under and pursuant to the provisions of Section 1. Public Law 95, Fifth Guam Legislature, Section 2(b), Public Law 137, Fifth Guam Legislature, and Section 3, Public Law 6, Sixth Guam Legislature, may be used for surfacing of roads at the Paseo de Susuan and for the purchase of private lands in the Agana Swamp where deemed necessary in accordance with the reclamation program of the Agana Swamp.

Section 2. This Act is an urgency measure.
