Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the operation of the Executive Branch of the Government of Guam for the fiscal year ending June 30, 1963;

Section 3. Any grant received from the United States Government as general fund revenue, is specifically authorized for the purpose, or purposes, for which much grant is made.

Section 4. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Six Mandred Thousand Bollars (\$600,000) for the Executive Branch's contribution to the Government of Quan Retirement Fund for the fiscal year ending June 30, 1963.

Section 5. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Two Hundred Fifty Thousand Bollars (\$250,000) for allowable travel and transportation expense of the Executive Branch of the Government of Guom for the fiscal year ending June 30, 1963.
