AN ACT MAKING A SUPPLEMENTAL APPROPRIATION FOR EXECUTIVE BRANCH TRAVEL FOR THE FISCAL YEAR ENDING JUNE 30, 1965, AN APPROPRIATION FOR THE WORKMEN'S COMPENSATION FUND, AND FOR CLEANING DEBRIS.

BE IT ENACTED BY THE PROPLE OF THE TERRITORY OF GRAM:

Section 1. The sum of \$450,000 is hereby apprepriated from any available funds in the Unapprepriated Surplus of the General Fund to supplement the appropriation made by Section 5, Public Law 6-115, for allowable travel and transportation expense of the Executive Branch of the Government of Guam for the fiscal year ending June 30, 1963.

Section 2. The sum of \$10,000 is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the Workman's Compensation Fund established by Section 37042 of the Government Code of Guam.

Section 3. The sum of \$300,000 is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for cleaning of debris from public property.
