AN ACT MAKING AN APPROPRIATION FOR THE OPERATION  
OF THE LEGISLATIVE BRANCH OF THE GOVERNMENT OF  
GUAM FOR THE CALENDAR YEAR ENDING DECEMBER 31,  
1963.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby reappropriated from the moneys  
3 appropriated by Public Law 127, Sixth Guam Legislature, the sum of Twenty-  
4 Five Thousand Dollars (\$25,000) for the operation of the Legislative  
5 Branch of the Government of Guam for the period beginning January 1, 1963,  
6 and expiring December 31, 1963.

7 Section 2. All expenditures and encumbrances charged on the  
8 books of the Government of Guam against the appropriation made by said  
9 Public Law 127, Sixth Guam Legislature, which are applicable to the period  
10 subsequent to December 31, 1962, shall be transferred on the books and  
11 charged against the appropriation made by this Act.

12 Section 3. There is hereby appropriated from any available  
13 funds in the Unappropriated Surplus of the General Fund the sum of One  
14 Hundred <sup>Eighty</sup> ~~Ninety-Four~~ Thousand Thirty Dollars <sup>(\$184,030)</sup> ~~(\$194,030)~~ for the operation  
15 of the Legislative Branch of the Government of Guam for the period beginning  
16 January 1, 1963, and expiring December 31, 1963, as a supplement to the  
17 moneys appropriated by Section 1 of this Act.

18 Section 4. This Act is an urgency measure.
