Public Law 7-89 Seventh Guam Legislature (Bill 208) February 13, 1964

AN ACT

An Act to repeal Section 11802 and to add a new Section 11820, both of Chapter 9, Title XII, Government Code of Guam relative to scholarships and student loans, and for other purposes.

Be it enacted by the People of the Territory of Guam:

Section 1. Section 11802, Government Code of Guam, is hereby repealed.

Section 2. New Section 11820, Chapter 9, Title XII. Government Code of Guam, is hereby enacted, to read as follows:

> "Section 11820. Board. As used in this Chapter, 'Board' means the Board of Regents of the College of Guam."

Section 3. The title of Subchapter A, Chapter 9, Title XII, Government Code of Guam, is hereby amended to read as follows:

"SUBCHAPTER A

Scholarships to the College of Guam"

Section 4. The title of Subchapter B, Chapter 9, Title XII, Government Code of Guam, is hereby amended to read as follows:

SUBCHAPTER B

Graduates of the College of Guam"

Section 5. Section 11800, Government Code of Guam, is hereby amended to read as follows:

"Section 11800. Students Entitled to Scholarship: Amount of Scholarship. There are hereby established annual scholarships to the College of Guam, to include textbooks, waiver of tuition and other fees for a period of not more than four years. Recipients of such scholarships shall be selected from the high school students in each graduating class of the several public and private high schools in Guam, now or hereafter established, who have completed four years of high school, of which at least the last year shall have been in Guam, and who are among the highest 20% of their class in scholastic standing. Each graduating class of said schools is entitled to one such scholarship as herein provided, and in addition for every twenty-five (25) graduates, or fraction thereof, an additional scholarship is provided. Each school shall make the selection based on scholarship, aptitude, interest, health, personality, ambition, and other criteria in accordance with regulations of the Board."

Section 6. Paragraph (3) of Section 11807, Government Code of Guam, is hereby amended to read as follows:

"(3) Preference shall be given to applicants who have graduated from the College of Guam;"

Section 7. This Act is an urgency measure.
