AN ACT MAKING SUPPLEMENTAL APPROPRIATION FOR CERTAIN CAPITAL IMPROVEMENT PROJECTS AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The following sums are hereby appropriated, from any available funds in the Unappropriated Surplus of the General Fund, to supplement prior appropriations for the projects set forth as follows:

- (a) Yona Commissioner's Office
- \$ 2,700.
- (b) Agat Commissioner's Office

850.

(c) Construction of temporary classrooms 34,700.

Section 2. The following sums are hereby appropriated, from any available funds in the Unappropriated Surplus of the General Fund, to supplement funds allocated by the Office of Emergency Planning for the following purposes:

- (a) Site improvements and facilities, including streets, curbs, driveways, walkways, septic tanks and final grading for new government housing \$ 70,000.
- (b) Exceptional Children School, to include an Administration Building 65.000.
- (c) Construction of the Rehabilitation

 Center 55.000.
- (d) Dededo Public Health and Public
 Safety facilities 10.000.

Section 3. The sum of One Hundred Fifty Thousand Dollars (\$150,000.) is hereby appropriated, from any available funds in the Unappropriated Surplus of the General Fund, to the Public Utility Agency Fund.

Section 4. The appropriations made by this Act shall be effective immediately, and shall be available for all expenses incident to the purposes for which made. Every appropriation made herein shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.

Section 5. This Act is an urgency measure.
