Committee on Rules, by request of the Governor in accordance with Section 6(b) of the Organic Act of Guana.

AN ACT TO PROVIDE FOR GOVERNMENT EMPLOYER'S INCENTIVE AWARDS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAR:

Section 1. Section 3006, Government Code of Guam, is hereby
enacted to read as follows:

"Section 3006. Incentive Awards. There is hereby established an employee incentive awards program which shall provide for the payment of cash awards to, and the honorary recognition of amployees, other than those in the unclassified service, of the Government who by their suggestion, inventions, superior accomplishments, or other personal efforts contribute to the efficiency, ecosony, or other improvement of Government eperations or who perform special acts or services in the public interest in connection with or related to their official employment."

Section 2. Section 3007, Government Code of Guam, is hereby enseted to read as follows:

"Section 3607. Same. Cash awards. A cash award shall be in addition to the regular compensation of the recipiest and its ecceptance shall constitute an agreement that the use by the Government of any idea, method or device for which the award is made shall not form the basis of a further claim of any mature upon the Government by the employee, his heirs, or assigns."

Section 3. Section 3008, Government Code of Guam, is hereby exacted to read as follows:

"Section 3008, Same, Incentive Award Board, The incestive award program shall be administered by a Board composed of the Director of Labor and Personnel, Chairman, and four members, all of whom shall be employees of the Government of Guam, appointed by the Governor. Cash awards shall be is such amount, not to exceed \$100 as the Board may determine. The Board shall edept needed rules and regulations for administration of the program, subject to approval by the Governor, and shall annually report results of the program, and its resommendations relative thereto, to the Governor and the Legislature," Section 4.
