AN ACT TO REPEAL FECTION 605 AND 609 OF CHAPTER IX, DIVISION III, PROBATE CODE; TO ENACT NEW SECTIONS 605 AND 609 TO CHAPTER IX, DIVISION III, PROBATE CODE; AND TO AMEND SECTION 644 OF ARTICLE II, CHAPTER X, DIVISION III, PROBATE CODE; RELATIVE TO APPOINTMENT AND COMPENSATION OF APPRAISERS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Sections 605 and 609, Probate Code of Guam, are hereby repealed.

Section 2. New Sections 605 and 609 are hereby added to Chapter IX, Division III, Probate Code of Guam, to read as follows:

"Section 605. Appointment of appraisers. To make the appraisement, the court or judge must appoint one qualified, disinterested person.

"Section 609. Compensation of appraisers. Each appraiser is entitled to receive, from each estate he appraises, his actual and necessary expenses and reasonable compensation for his services, to be allowed by the court; and he must file, with the inventory, a verified account of his services and disbursements.

Section 3. Section 644 of Article II, Chapter X, Division III, Probate Code of Guam, is hereby amended to read as follows:

"Section 644. Appointment of appraiser. When a petition is filed which includes the allegations provided for by Section 640 or Section 641, unless the whole estate consists of money, the court may forthwith appoint one qualified, disinterested appraiser, who shall appraise the property described in the petition, and file his report with the clerk of the court."
