**AN ACT MAKING APPROPRIATIONS FOR NECESSARY CAPITAL
IMPROVEMENTS AND FOR OTHER PURPOSES.**

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund, for the purposes set forth herein:

a. Off Island Legal Services	\$ 25,000
b. Civil Defense Communication and Warning Device	8,000
c. Summer Youth Activities	10,000
d. Economic Opportunity Projects	44,000
e. Government Contribution to Employee Group Health Insurance	63,000
f. Salary Increment Adjustments	100,000
g. Workmen's Compensation	15,000
h. Outdoor Recreation Projects	43,500 43,500
i. Barrigada School Drainage	13,000
j. Sisters' Quarters	35,000
k. Architectural Plans for Dededo School Extension	15,000
l. Governor's Contingency	25,000

Section 2. The sum of \$156,600 is hereby reappropriated from the appropriation made by Section 1 of Public Law 123, Fifth Guam Legislature, to supplement prior appropriations made for the construction of:

a. Civilian Air Terminal	\$110,000
b. School for Exceptional Children	28,600
c. Vocational Rehabilitation Center	18,000

Section 3. The appropriations made by this Act shall be effective immediately, and shall be available for all expenses incident to the purposes for which made. Every appropriation made herein shall continue in full force and effect and shall be available until expended for the project for which the appropriation is made or until the project is completed.
