AN ACT MAKING AN APPROPRIATION FOR THE OPERATION AND CAPITAL
OF THE GUAM ECONOMIC DEVELOPMENT AUTHORITY FOR THE FISCAL YEARS
ENDING 30 JUNE 1966 AND 30 JUNE 1967.

1 Be it enacted by the People of the territory of Guam, That there hereby is
2 appropriated from any available funds in the Unappropriated Surplus of the General
3 Fund the sum of ~~One Hundred Ninety Thousand Five Hundred Dollars (\$190,500)~~ ^{One Hundred Twenty-Five Thousand} ~~(\$125,000)~~ ^(\$125,000) for
4 the capital of the Guam Economic Development Authority. This section shall be
5 effective upon the approval of this Act.

6 Section 2. There is appropriated from any available funds in the Unappro-
7 priated Surplus of the General Fund the sum of Three Hundred Nine Thousand Five
8 Hundred Dollars (\$309,500) for the capital and operation of the Guam Economic
9 Development Authority. The unencumbered balance from the operating capital for
10 fiscal year 1966 of the Guam Economic Development Authority is hereby made available
11 to said corporation to supplement its capital and operating funds. This section
12 shall become effective 1 July 1966.
