AN ACT TO AMEND SUBSECTION 1 OF SECTION 82, CODE OF CIVIL PROCEDURE, AND SECTION 1571, PENAL CODE OF GUAM RELATIVE TO PROSECUTION OF MISDEMEANORS INCLUDED IN FELONIES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Subsection 1, Section 82, Code of Civil Procedure of Guam is hereby repealed in its entirety and in lieu thereof a new Subsection 1 is hereby enacted to read as follows:

"Section 1. In all criminal cases not amounting to felonies, arising under the laws of Guam; provided, that in a prosecution for a felony, the District Court of Guam shall have jurisdiction over any offense necessarily included in such felony or an attempt to commit such felony or of an offense necessarily included in such an attempt if the attempt is an offense."

Section 2. Section 1571 of the Penal Code of Guam is hereby

amended to read as follows:

"Section 1571. Trial by Jury, Any person accused by information or indictment of a felony in the District Court of Guam shall be entitled to a trial by jury for any offense for which said Court has jurisdiction under Section 82(1) of the Guam Code of Civil Procedure as now or hereafter amended, and the Federal Rules of Criminal Procedure heretofore or hereafter promulgated shall be applicable thereto."
