AN ACT MAKING AN APPROPRIATION FOR THE ANNOTATED
RECODIFICATION OF THE CODES AND OTHER LAWS OF GUAM.

1 Be it enacted by the People of the territory of Guam, That there is hereby
2 appropriated from any available funds in the Unappropriated Surplus of the General
3 Fund the sum of ~~Ten Thousand Dollars (\$10,000)~~ ^{Five Thousand Dollars (\$5,000)} for the annotated recodification of
4 the Codes and other laws of Guam pursuant to Public Law 8-58. This Section shall
5 be effective upon the approval of this Act.

6 Section 2. There is hereby appropriated from any available funds in the
7 Unappropriated Surplus of the General Fund an additional sum of ~~Eighty-Eight~~ ^{Sixty-Eight}
8 ~~Thousand Nine Hundred Dollars (\$88,900)~~ ^{Thousand Nine Hundred Dollars (\$68,900)} for the annotated recodification of the
9 Codes and other laws of Guam pursuant to Public Law 8-58. This Section shall
10 become effective on 1 July 1966.
