AN ACT TO AMEND TITLE XXI OF THE GOVERNMENT CODE OF GUAM RELATIVE TO RENTAL HOUSING GUARANTEES.

Be it enacted by the People of the territory of Guam, That a new Subsection (d) is hereby added to Section 20002, Government Code, to read as follows:

"(d) To encourage and promote the construction of housing units for rent within the capacity of families of low and moderate income. To assist in the development of tourist hotel facilities as provided in this chapter."

Section 2. Section 20010, Government Code of Guam as enacted by Public Law 8-81, is hereby renumbered Section 20011 of Title XXI, Government Code of Guam.

Section 3. Section 20011, as renumbered by Section 2 hereof is hereby amended to read as follows:

"Section 20011. Tourist Hotel Facilities.

"(a) The Housing Corporation is authorized in addition to the powers conferred upon it by this Chapter, to guarantee payment of loans in an amount not to exceed the lesser of \$1,500,000 or Seventy-Five percent (75%) of the total development and construction cost of any one project for the development and construction of tourist hotel facilities in Guam, the total cost of the development and construction of no one of which hotel facilities shall be not less than \$1,500,000 and may pledge its assests in support thereof.

"(c) The Governor of Guam, with the concurrence of the Committee on Rules of the Guam Legislature, is authorized to execute such documents as may be required to assure the integrity of a guarantee given pursuant to this Section, and, to that end, may pledge the full faith and credit of the Government of Guam.

"(d) In the event of default in payment on any loan guaranteed, in accordance with applicable regulations, it shall be the primary responsibility of the Housing Corporation to make such payments as may be required in support of its obligation, if the Housing Corporation, for whatever reason, is unable to do so either in whole or in part, any deficiency therein shall be met by appropriation."
