

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

This is to certify that Substitute Bill No. 288, "An Act adding a new Section 13514.5 to Chapter 6 of Title 14 of the Government Code of Guam relative to the reimbursement of persons evicted from Government Land occupied under leases and land use permits", was on 15 June 1966 duly and regularly passed; that on 16 June 1966 said bill was presented to the Governor of Guam; that on 28 June 1966 the Governor of Guam returned said bill to the Guam Legislature with his objections; that on 29 June 1966 the Guam Legislature entered said objections at large on its journal; that on 29 June 1966 the Guam Legislature reconsidered said bill; and that on 29 June 1966 two-thirds of the Guam Legislature duly and regularly agreed to pass said bill and the same was duly and regularly passed by said two-thirds of the Guam Legislature.

AN ACT ADDING A NEW SECTION 13514.5 TO CHAPTER 6 OF  
TITLE 14 OF THE GOVERNMENT CODE OF GUAM RELATIVE TO  
THE REIMBURSEMENT OF PERSONS EVICTED FROM GOVERNMENT  
LAND OCCUPIED UNDER LEASES AND LAND USE PERMITS..

1 Be it enacted by the People of the territory of Guam, That the  
2 following new Section 13514.5 is added to Chapter 6 of Title 14 of the Govern-  
3 ment Code of Guam:

4 "Section 13514.5. Reimbursement of eviction damages. Any person  
5 not in default evicted from Government of Guam land occupied by such person  
6 under a lease or land use permit shall, pursuant to chapter 6 of Title VII of  
7 the Government Code of Guam, be indemnified by the government of Guam for all  
8 loss of crops and permanent plants suffered by such person as a result of such  
9 eviction."
