Section 1. Section 2956 of the Civil Code of Guam is hereby amended

as follows:

"Section 2956. Form, personal mortgage. (a) A chattel mortgage shall be deemed to be sufficient when made substantially in accordance with the following form, and shall be signed by the person or persons executing the same.

FORM OF CHATTEL MORTGAGE

The conditions of this obligation are such, that if the mortgagor, his heirs, executors, or administrators, shall well and truly perform the full obligation above stated according to the terms thereof, then this obligation shall be null and void.
