AF ACT TO EMPRAL SECTIONS 192 AND 193 OF, AND ENACT NEW SECTIONS 192 AND 193 TO, CHAPTER I, TITLE VIII, PART I, PENAL CODE OF GUAN, RELATIVE TO THE OFFENSE OF MAN-SLAUGRITER.

BE IT EMACTED BY THE PROPIE OF THE TERRITORY OF QUAN:

Section 1. Sections 192 and 195, Femal Code of Guan, are hereby repealed in their entirety.

Bection 2. A new Bection 192, Penal Code of Guam, is hereby added to read as follows:

"Section 192. Menslaughter defined: Tinds.

Manalaughter is the unlawful killing of a laumen being, without malice. It is of three kinds:

- 1. Voluntary-upon a sudden quarrel or heat of passion.
- 2. Involuntary-in the possission of an unlawful act, not amounting to a felony; or in the consission of a lawful act which might produce death, in an unlawful manner, or without due emution and circumspection; provided that this subdivision shall not apply to acts committed in the driving of a vehicle.
 - 3. In the driving of a vehicle -
 - (a) In the commission of an unlawful act, not amounting to a felony, with gross negligence; or in the commission of a lawful act which might produce death, in an unlawful manner, and with gross negligence.
 - (b) In the commission of an unlamful act, not emounting to felony, without gross negligence; or in the commission of a lawful act which might produce death, in an unlawful manner, but without gross negligence.

This Section shall not be construed as making any homicide in the driving of a vehicle punishable which is not a proximate result of the commission of an unlawful act, not smounting to felony, or of the commission of a lawful act which might produce death in an unlawful manner."

Section 5. A new Section 195, Penal Code of Guam, is hereby maded to read as follows:

"Section 193. Pumishment of manslemghter.

- 1. In the case of violation of Subsection 1 of Section 192, punishment shall be for imprisonment for not exceeding ten (10) years or by fine not exceeding \$5,000.00, or by both.
- 2. In the case of violation of Subsection 2 of Section 192, punishment shall be for imprisonment for not exceeding three (3) years or by fine not exceeding \$1,000.00, or by both.
- 5. In the case of violation of Item (a), Subsection 3 of Section 192, punishment shall be for imprisonment for not exceeding three (3) years or by fine not exceeding \$3,000.00, or by both.
- 4. In the case of violation of Item (b), Subsection 3 of Section 192, punishment shall be for imprisonment for not exceeding one (1) year or by fine mot exceeding \$1,000.00, or by both."

Section 4. This Act is an urgency measure.
