



Introduced by: R. F. TAITANO

1 AN ACT ADDING A NEW SECTION 53568.1 TO THE GOVERNMENT  
2 CODE OF GUAM, LIMITING THE ISSUANCE OF QUALIFYING CERTI-  
3 FICATES UNDER TITLE LIV OF SAID GOVERNMENT CODE OF  
4 GUAM TO MANUFACTURERS OF WATCHES, WATCH MOVEMENTS AND  
5 TIMING APPARATUS.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 See PL 10-43 - *Repealed*  
3 Section 1. Section 53568.1 is hereby added to the Government  
4 Code of Guam to read as follows:

5 "Section 53568.1. Same. Legislative findings. Limitation to  
6 Watch Manufacturers. The Legislature finding that the issuance of additional  
7 Qualifying Certificates to watch assembly companies would not be in the best  
8 interest of the existing industry, that no further incentives are required to  
9 attract watch companies to Guam, and that the issuance of additional  
10 certificates might well create problems with respect to the duty-free  
11 status of Guam's exports, no Qualifying Certificates may be issued after  
12 January 1, 1967 to any applicant engaged in the manufacture or assembly  
13 of watches, watch movements, clocks or timing devices in the territory of  
14 Guam. The limitation set forth in this section on the further issuance  
15 of Qualifying Certificates to watch manufacturers shall in no way  
16 affect the validity of the Qualifying Certificates issued by the Governor  
17 to such watch manufacturers prior to January 1, 1967."

Section 2. This Act is an urgency measure.
