



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT TO AMEND THE FIRST PARAGRAPH OF SECTION
25210.1 OF THE GOVERNMENT CODE OF GUAM RELATING
TO THE ISSUANCE OF GENERAL ON-SALE LIQUOR LI-
CENSES UNDER THE ALCOHOLIC BEVERAGE CONTROL ACT
AND TO ADD SECTION 25126 TO SAID CODE TO PROVIDE
SPECIAL AIR TERMINAL LICENSES FOR SALE OF ALCOHOLIC
BEVERAGES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The first paragraph of Section 25210.1 of the
Government Code of Guam is hereby amended to read as follows:

"Section 25210.1. Same: same: number, cancellation, or is-
suanee of licenses in excess of authorized ratio: application:
hearing. The number of premises for which an on-sale general
license or an off-sale general license is issued shall be li-
mited to one (1) for each 1,000 or fraction thereof, inhabitants
of the municipality in which the premises are situated, provided,
however, that without regard to such population limitation, a non-
transferable, on-sale, general license may be issued for any hotel
of not less than 20 rooms, or for any premises designed to provide
restaurant facilities for the public in which the investment in
buildings is not less than \$50,000. No on-sale general license
shall be issued in lieu of or upon the cancellation or surrender
of an on-sale beer and wine license, except in case of an increase
in population as provided hereafter."

Section 2. Section 25126 is hereby enacted to read as follows:

"Section 25126. Air Terminal Licenses.

(a) On-sale license. A special license authorizing the sale
of alcoholic beverages for consumption on the premises may be issued
to any person granted a concession for that purpose at the air
terminal.

1 (b) Export sales. A special license authorizing sale of
2 alcoholic beverages to a non-licensee for export may be issued to
3 any person granted a concession for that purpose at the air ter-
4 minal. Any such export sales shall be exempt from tax to the
5 extent and in the manner provided by Section 25117.

6 (c) Licenses authorized by subsections (a) and (b) shall
7 not be transferable, and their continuance shall be conditioned
8 upon compliance with all terms applicable to operation of the
9 concession as established by terminal management. No concession
10 shall be granted to any person not meeting requirements of law
11 applicable to licensees generally, and its operation shall be
12 subject to compliance with law and regulation by the Board in
13 the same manner as other licensed premises."

14 Section 5. This Act is an emergency measure.
